

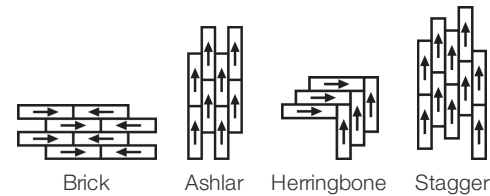





### Color and Visual Variation Index


