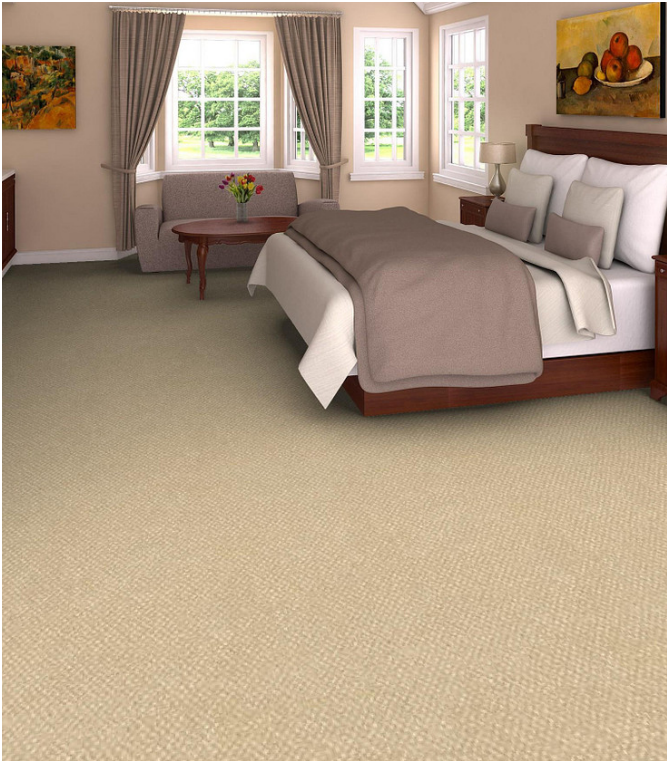

Direct Glue, Double Glue, Stretch-In

Product should be installed in residents rooms only applications. No more than two drops in width, and room lengths no greater than 25 feet is required.

When installing all carpeting, Stretch-In over pad is recommended. For hybrid locations with carpet and resilient, direct glue with LokSeam is recommended.

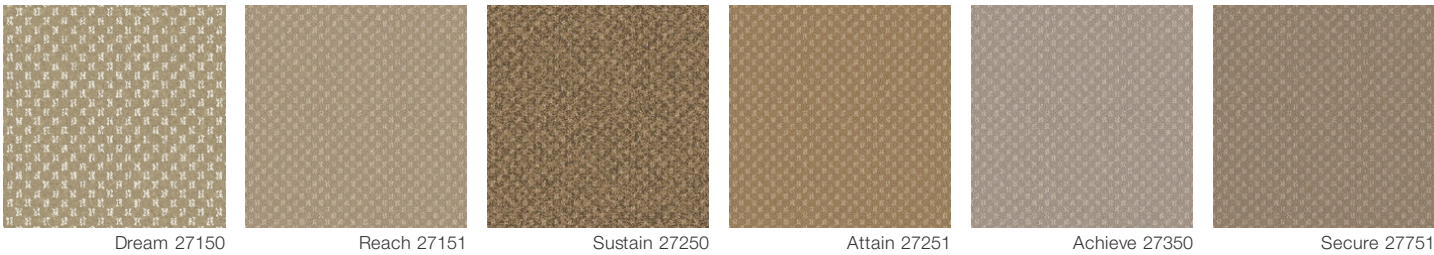
